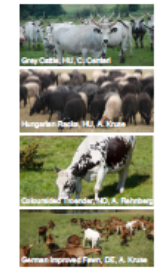
Where? How? Extend of Transhumance?



Dominating animals: sheep, cattle, goats, among these many regional breeds.

While transhumance still is practiced all over Europe, form and intensity varies.

What is produced where?



Vertical, horizontal, urban transhumance. Livestock moves from: a) lowlands to higher elevation areas, b) stables to summer pastures, often including 1, 2 intermediate levels, c) winter pastures in low-elevation. In the mountains, stay at seasonal farms or moving from pasture to pasture. Gaining importance: Urban transhumance and transhumance-like grazing for land management purposes.

Main challenges expressed by 46 interviewed transhumance practitioners across Europe

Challenges – Future needs

- Maintain and develop transhumance throughout the countries
- Make the transhumance profession attractive enough to compete with other land users and types of farming in the rural sector
- Facilitate access to pastures especially in the lowlands
- Ease administration, e.g. for crossing departmental roads
- Foster and valorise intergenerational knowledge transfer
- Support platforms for knowledge exchange
- Extent / found educational offers – at specialized schools but also by training on the job
- Include new topics in training curricula, e.g. communication, wolf protection, online marketing etc.
- Acknowledgement & valorisation

Summary State of the Art

Interviews with transhumance practitioners, analysis of statistical data and literature have clearly highlighted that transhumance is still practiced with a broad range of different types in Europe. It enriches rural areas, providing attractive and diverse landscapes, tangible and intangible heritage, high-quality food & products, ecosystem services. It suffers from a declining numbers of practitioners. The decline has not only impact on transhumance landscapes and culture. It also reduces learning opportunities for practitioners. Education offers and the degree to which they are institutionalised differ strongly among the partner countries already now. Legislation, rules, financial support and recognition differs strongly among the countries. Access to land gets more and more difficult and bureaucratic. Needs raising awareness about it's culture, benefits and the needs of practitioners is important in this respect. Faces challenges and worries about future economic support and viability, meaning that increased and secured economic incentives targeted at transhumance practitioners are important for the future of transhumance.

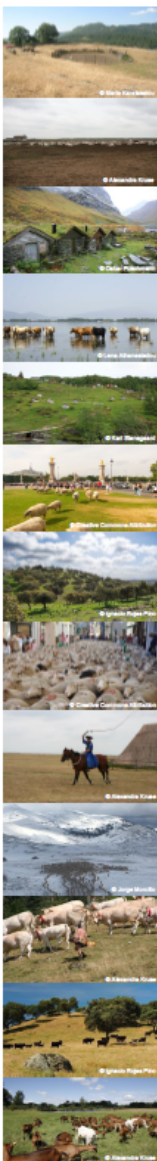

Speaking a common language: The Transfarm Glossary

Transfarm aims at permitting various stakeholders to speak a common language in order to understand the same content, to realise common decisions and to act on equal level – also beyond borders.

- 25 terms with definitions in English and various illustrations with national perspectives
- Terms translated in 10 languages: Czech, Dutch, French, German, Greek, Hungarian, Italian, Norwegian, Slovakian & Spanish.

The glossary is divided into 5 thematic topics:

- Transhumance as activity
- People practising transhumance
- Transhumance animals
- Used land, including buildings
- Transhumance landscapes and transhumance related landscape elements.

Transhumance is a form of mobile, livestock farming with a regular, seasonal, cyclical long-distance movement of livestock (especially sheep, cows, and goats, but also horses, donkeys, and reindeer) accompanied

by people between different geographical, sometimes also different climatic regions along steady routes, which lasts several months.

- Transhumance has regular permanent winter farms.
- Transhumance is related to fixed houses of different types for the different locations used during the drive.
- We distinguish three forms: vertical, horizontal, and urban transhumance.
- Transhumance is unlike nomadism and semi-sedentary systems.

Illustration	Definition
	Alp Vast area of high mountain pasture / alpine pasture. The pasture landscape (alp) includes buildings, where herders respectively dairymaids/dairymen spend several months. Furthermore, alp is a synonym for common land in the mountains. In some countries, summer farm is a synonym for alp.
	Common land Land, that is used by the community of one or several municipalities respectively (all) farmers of an area. Common land still exists today, e.g. in mountain regions (such as the Alps) or on transhumance pathways.
	Dairymaid, dairymaid Persons which produce milk and cheese on both, seasonal farms and alps, but who do not, in the first place, take care of the herds.
	Dehesa / Montados The Dehesa (Spanish) or Montados (Portuguese) systems are Mediterranean wood pastures, combining native trees such as holm oak, cork oak with grasslands. The resulting landscape, which combines mature ecological elements (oak trees) with other rejuvenated ones (grasslands), maintains high biodiversity. These landscapes reached their highest extent under the influence of the growth of long-distance transhumance.
	Drive from the mountain pasture Festive driving the herds down from the high mountain pastures, the conclusion of the Alpine pasture grazing season and beginning of winter season (animals kept in sheds).
	Drive to the mountain pasture Driving herds to the mountain pastures, starting of the Alpine pasture grazing season.
	Ephemeral building (shieling) Non-permanent (not solid, spontaneously erected) seasonal (farm) construction erected for shelter. Occupied by shepherds or youngsters traveling with the animals to the summer pastures. The shieling is the archetypical building connected to transhumance.
	Flock Group of animals which do transhumance, can be of the same species or of different ones. Synonyms: livestock, herd, herd animals
	Heathland Heaths are shrub land habitats characterized by open, low-growing woody vegetation, found on mainly infertile acidic, respectively poor soils. They are similar to moorland, but they differ in terms of climate and vegetation. Heathland is generally wetter and drier than moorland. Heathlands can be found at the coastline (e.g. Mediterranean coasts) as well as on the plain land itself (e.g. Germany).

Illustration	Definition
	Herder *The person that takes care of the livestock and moves with them. In some countries, herders do also produce cheese, etc. In others not. Synonyms: herdman, herdswoman, guide, stockman, pastoralist. There are many national terms and those, specifically according to the animal, e.g. shepherd?
	Horizontal transhumance Horizontal transhumance, occurring in plain or plateau regions where herders and their livestock migrate across long distances from the summer pastures far from their homes to the winter pastures close to their homes. The herd is accompanied by at least one herd person and several dogs. Today, often movable fences are erected for each grazing stop. During the transhumance movement, the herd people don't have fixed houses. Sometimes, mobile homes are either at disposal or are brought to right places by other family members.
	Nomadism Systems are based on the extensive movement of herds and flocks in search of forage, led by human family units with no permanent home base. A way of life in which a community has no permanent settlement but moves from place to place, usually seasonally and within a defined territory. For the purpose of the TRANSFARM project, this is not treated.
	Pasture Pasture also called rangeland, grassed land also includes non-grassland habitats such as heathland, moorland, and wood pasture. Pasture growth can consist of grasses, legumes, other forbs, shrubs, or a mixture.
	Postfold Place where flock can be gathered together for different purposes: stop and graze in a protected environment, especially at night, veterinary intervention, milking, marking, giving birth, newborns. Enclosure can be made of hurdles, simple wooden fences, stones, but also wires and metal. In Italy only known for ovine and both, a structure and a right. There are a lot of them, sometimes very ancient, not used anymore.
	Ranger Today, also ranger can be herders if they accompany herds in protected areas.
	Seasonal farm Name for individual farms and pastures with related buildings which are used for a certain time of the year. The area is smaller than for common land or alp. Wooden houses for a living, storing hay, cheese production, and sometimes also tourism. The farm includes welcoming-, summer- and autumn farms with many national terms, differentiating season, architecture, material, and location.
	Seasonal farmstead Individual seasonal but permanent farm building, used in (high) altitude only in summer for living and production. There are many national-specific types. Synonyms: shieling, helof.
	Sheep dogs Special, often regional, breeds, which are specially trained to watch and protect the flock.
	Transhumance practitioners Generic term for all people related to transhumance in one way or another: farmers & animal owners, herders, dairymaids/dairymen.
	Transhumance route Route for driving livestock on foot (or on horses, sometimes with vehicles, esp. in Scandinavia) from one place to another, between summer and winter pasture. Many transhumance roads were ancient routes of unknown age; others are known to date back to medieval or more recent times. Synonyms: transhumance route, pathway, dirt way Notes: Drive/drove route/drove way which means the route to the animal markets, which is only one-way, while transhumance is always two ways respectively a loop route.
	Urban transhumance An urban transhumance is a special form of horizontal transhumance as a new (sustainable) way of maintaining grassland in the urban context. Herds move along defined shorter routes along with parks, dyes, and private grounds, accompanied by herders and dogs. It is often combined with education, green infrastructure, sustainability, and other topics.
	Vertical transhumance Vertical transhumance, occurring typically in mountain regions where the animals are driven among low-altitude pastures and high-altitude pastures.
	Water supply Transhumance requires water supply which is often based on sometimes very old artificial installations: e.g. small ponds, but also channels, wells, stand posts or even movable reservoirs. Synonyms: dewpond, a pond constructed to maintain a supply of water in an area of high permeability.

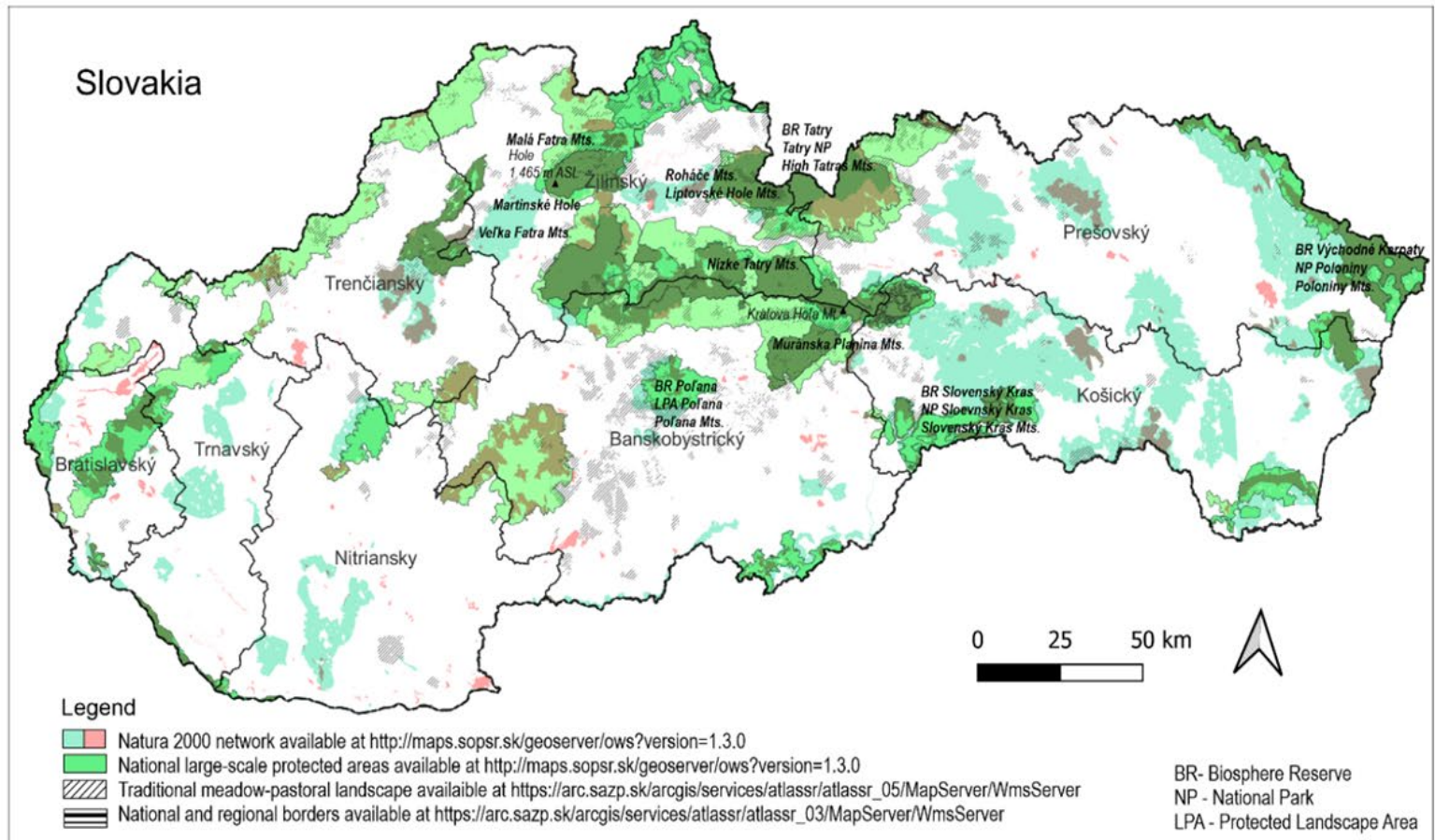

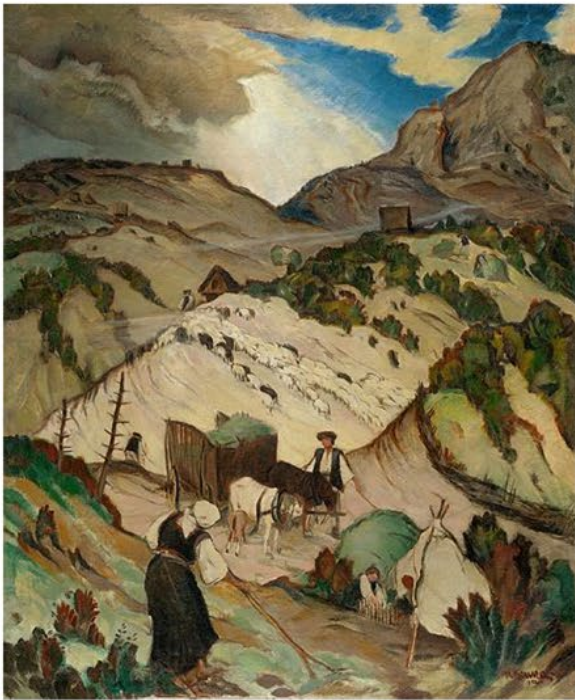

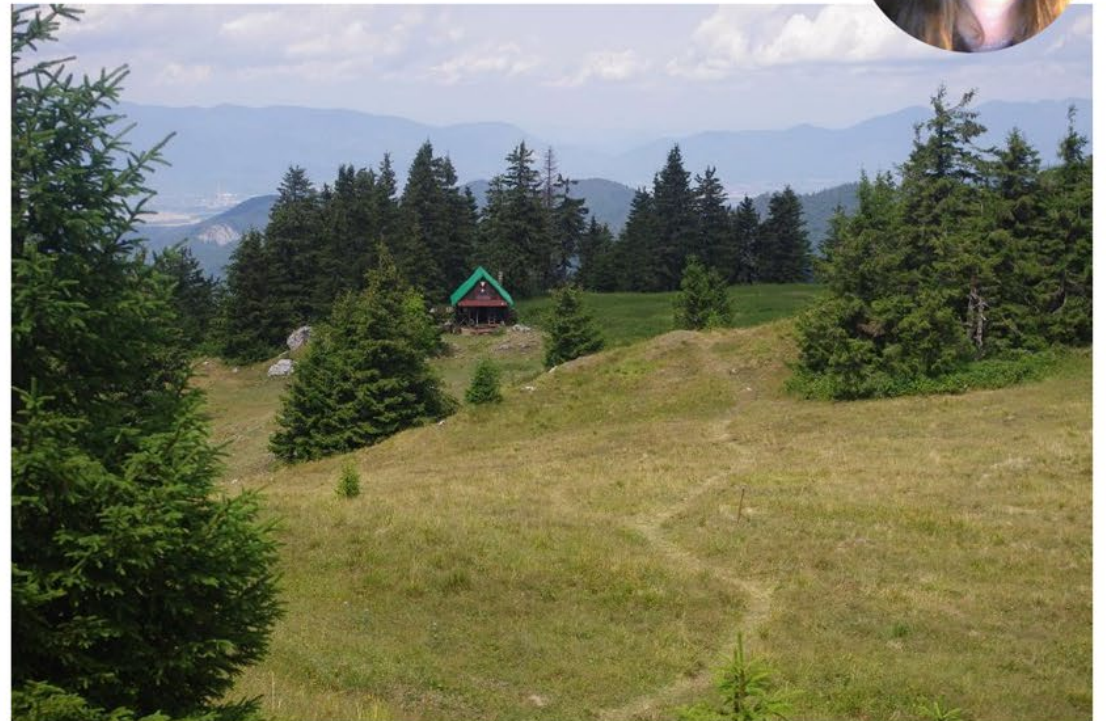

Mountain shepherding is integral and typical part of Slovak history and culture.



Promotion of sheep products on the main road of the village of Liptovské Revúce and tourist trail by the local agricultural company PD Liptovské Revúce.

The Association of Sheep and Goats Breeders (<https://zchok.sk>) organises (besides other activities) regular festivals known at national level (Ovenálie, Demeter) and into International Sheep Shearing Championship of the SR, local products markets and registration of original sheep and goats products.

- Cultural phenomena are associated with specific folklore and musical instruments e.g. *fujara*, pipes,
- Shepherds dishes, e.g. *črpáky*, clothing, work artifacts e.g. *valaška*, etc.
- Culinary specialities represent dairy foods: *oštiepok*, *parenica*, *bryndza*, *žinčica*.
- Shepherds dogs.
- Museums.

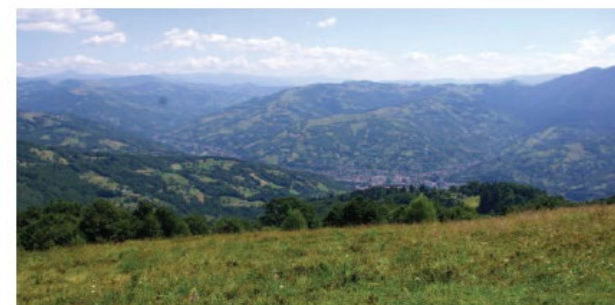

Spoznávanie ekofariem v Zakarpatskej oblasti Ukrajiny

Katedra UNESCO pre ekologické vedomie a trvalo udržateľný rozvoj bola pozvaná prostredníctvom Európskej kancelárie Sekretariátu Karpatského dohovoru so sídlom vo Viedni (Program OSN pre životné prostredie Viedenské medzinárodné centrum) na terénnu exkurziu v rámci projektu „Green and inclusive agricultural policy – steps towards“, ktorý realizuje informačné centrum „Green Dossier“ z Ukrajiny s podporou Európskej únie a International Renaissance Foundation v rámci programu „European Renaissance of Ukraine“. Exkurzia spojená s odborným výkladom a interview s farmármi sa uskutočnila počas slnečných horúcich letných dní od 10. – 12. júla 2024. „Green Dossier“ je medzinárodná environmentálna charitatívna organizácia, ktorá bola založená v roku 1994 a pôsobí v Karpatoch už viac ako 20 rokov v úzkej spolupráci so Sekretariátom Karpatského dohovoru.

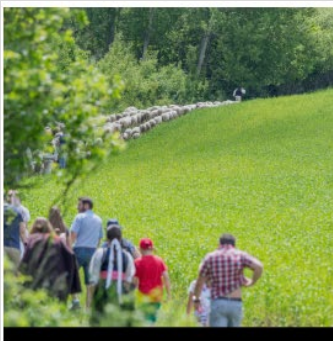

„Tradičné ovčiarstvo“ bolo 15. januára 2025 zapísané na [Reprezentatívny zoznam nehmotného kultúrneho dedičstva Slovenska](#). Bola tým splnená prvá podmienka na to, aby sa mohlo usilovať o zápis na prestížny UNESCO Reprezentatívny zoznam nehmotného kultúrneho dedičstva ľudstva.

Transhumancia – sezónne pasenie zvierat – už je súčasťou tohto zoznamu UNESCO a Slovensko by sa spolu s ďalšími 9 krajinami chceli k tejto medzinárodnej nominácii pripojiť. Naša nominácia sa v týchto mesiacoch finalizuje a pre jej úspešné podanie je potrebná koordinácia a zaangažovanie viacerých relevantných aktérov.
